Terms & Conditions

- 1. Approved travel agents will arrange to book air tickets on domestic and international flights of all airlines including emergency booking/ booking in odd situations.
- 2. They will have to mail or deliver tickets at the High Commission's office / email addresses High Commission's concerned officers.
- 3. Approved travel agent will not claim any commission / charge for booking of air tickets
- 4. The booking will be done on credit basis.
- 5. Bills for bookings shall have to be submitted on a weekly basis and subject to the correctness of the bill the payment will be generally made within a week's time.
- 6. The arrangements with the Travel Agent shall stand terminated in the case of insolvency of the travel agents or them entering into any arrangement/ compensation with their creditors.
- 7. The High Commission reserves the right to avail of the services of one or more travel agents.
- 8. The Travel Agent shall ensure uninterrupted services taking into account the holidays followed by the High Commission. In the event of poor/ deficient service the High Commission reserves the right to terminate forthwith the arrangement with the Travel agent.
- 9. The application shall be only the form issued by the High Commission for submitting the applications.
- 10. The application form shall be signed by a person on behalf of the organization who is duly authorized to do so.
- 11. If the space in the application form is insufficient for furnishing full details, such information may be supplemented on a separate sheet of paper duly signed.
- 12. Application containing false or inadequate information is liable for rejection.
- 13. The High Commission reserves the right to reject any or all the applications without assigning any reason thereof.
- 14. The validity of the empanelment of Travel Agent will be initially for a period of one year and the period is renewable for subsequent years at the discretion of the High Commission subject to conditions that the High Commission finds the service of the travel agent satisfactory.
- 15. The Firm/company should be established registered to operate for issuing the airlines tickets.
